- 2. Attach to the form a voided blank check (no deposit slips will be accepted) for the account from which the payment will be made. The check will not be returned to you. If funds will be taken from a savings account, take the form to your bank and ask them to complete the bottom portion of the authorization form and check the box that indicates savings account.
- 3. Return the form with the voided check to:
